## **Shiprock Department for Self Reliance Office Remains Displaced**

**Shiprock, New Mex.** – The Shiprock Department for Self Reliance (DSR) Office, which was located within the Ayani Nez building was officially closed on Wednesday, December 10, 2014 by order of the Navajo Nation Office of Environmental Health due to the substantial health and safety risks to the DSR's Customers, employees and visitors.

The DSR is currently looking for an office facility in the Shiprock area which will accommodate the Shiprock DSR Customers and staff. In the meantime, until the DSR establishes an office, the DSR will be providing limited services from the Department for Family Services office within the BIA building located off of Highway 491, south of the Post Office and west of the Senior Center in Shiprock, New Mexico.

The schedule of services for the temporary location for January 2015 is as follows:

- January 14th, Wednesday from 8:00 am to 5:00 pm, document submittals only.
- January 15th, Thursday from 8:00 am to 5:00 pm, document submittals only.
- January 21st, Wednesday from 8:00 am to 5:00 pm, document submittals only.
- January 22nd, Thursday from 8:00 am to 5:00 pm , eligibility intake and document submittals only.

Shiprock DSR itinerate sites will continue to operate as scheduled:

**NMHS Income Support – Farmington**, located at 101 W. Animas in Farmington, New Mexico.

- January 13th, Tuesday from 9:00 am to 4:00 pm
- January 20th, Tuesday from 9:00 am to 4:00 pm

**Aneth Chapter House**, located off of HWY 162 in Aneth, Utah.

- January 8th, Thursday from 9:00 am to 4:00 pm
- January 22nd, Thursday from 9:00 am to 4:00 pm
